## How to Join

### AFFILIATE MEMBERSHIP

The section accepts affiliate members who are interested in the study or practice of early education and child care and who are interested in contributing toward the objectives of the section.

Approved affiliate membership categories include:

- 1) Licensed physicians not eligible for Fellowship in the Academy,
- 2) Licensed health professionals such as nursing professionals, physician assistants, and registered dietitians,
- 3) Licensed mental health professionals such as counselors or social workers,
- 4) Educators or researchers with a masters or doctoral degree and relevant experience.

With the application for membership, an affiliate member candidate shall submit:

- 1) One letter from an AAP member who is a member of the Section on Early Education and Child Care or the Council on Community Pediatrics and has agreed to sponsor/mentor the applicant.
- 2) Copy of their license or diploma.

## Section on Early Education and Child Care

The American Academy of Pediatrics (AAP) is an organization of more than 60,000 pediatric medical, surgical, and multidisciplinary subspecialists committed to the attainment of optimal, physical, mental and social health for all children, adolescents, and young adults.

More than half of the AAP's members belong to one or more sections. Sections develop ideas and generate programs that improve the care of infants, children, adolescents, and young adults. Sections were developed within the AAP for members who are interested and/or trained in specific areas of pediatrics. Although their primary goal is education, sections are also involved in policy development, public education, and advocacy for children. As a section member you will have the opportunity to share ideas with and learn from colleagues who share your specific interests and/or subspecialty background.

In 2008, the Academy established the Section on Early Education and Child Care as a permanent section to provide a forum for pediatricians and others interested in promoting the optimal development, health, and safety of children in child care.

## Section Objectives

The objectives of the AAP Section on Early Education and Child Care are the following:

- Sustain a network of pediatric child care experts and health professionals to promote health/safety within child care programs and engage parents in discussions about quality care and their child care options.
- Increase the use of health and safety policies and practices in child care programs.
- Enable child care professionals to help families access medical homes and community resources.
- Maximize opportunities for health promotion in early childhood and ensure that children in child care enter school healthy and ready to learn.

**Child Care, Health, and Early Education and Research (CHEER) Consortium** – This group of health professionals and researchers facilitates and encourages other health professionals, caregivers, and researchers to collaborate on research projects and utilize results to improve the quality of care for children in early education and child care settings across the country.

A majority of young children are enrolled in out-of-home child care programs. High-quality early education and child care improves their development, health, and ability to learn. Partnerships with community colleagues can ensure that all young children have access to quality child care within a nurturing environment and have a medical home. By working as a team, community partners can maximize resources, develop comprehensive services, and most importantly nurture and protect children so they enter school healthy and ready to learn!
